The 5<sup>th</sup> European Policy Dialogue Forum (EPDF) is dedicated to addressing "Young People and Social Inclusion in Cities". In the bustling city of Rotterdam, Netherlands, from 13-15 November 2023, we are bringing to the forefront the challenges that young people face in urban communities, with a strong emphasis on the power of intercultural and interreligious dialogue.

The EPDF is a collaborative effort led by the International Dialogue Centre (KAICIID), in partnership with the European Council of Religious Leaders/Religions for Peace Europe (ECRL/RfP), the KAICIID-supported Network for Dialogue and the local partner Multicoloured Religions Rotterdam. We also have the valued support of the OSCE Office for Democratic Institutions and Human Rights (ODIHR) and the International Organization for Migration (IOM) in the Netherlands.

Our goal is clear: to **inspire, connect and engage** a diverse range of stakeholders, including religious actors, policymakers, civil society and young people, in our shared mission to foster more inclusive and harmonious cities across Europe. We aim to provide spaces for mutual learning through dialogue in action and build bridges between cultures and religions. We anticipate 120 participants from 30+ European countries, one-third aged 18-30.
