#### Sherin Ahmed, Chairwoman, Coexister Germany



Born in Munich in 2000, Sherin grew up in Cairo (2005-2011) and moved back to Germany as a result of the Arab Spring. She came into contact with interculturality and the importance of peace at an early age. While living in France (2018-2020), she got to know the association Coexister France. Enthusiastic about the idea of active coexistence, she founded this association with others during the pandemic (February 2021) in Germany. Today, she is the chairperson of the board. She is also studying social work in Freiburg and works as the regional coordinator for southern Germany in the Liberal Islamic Federation.

#### Jovan Aksentijević, Secretary of the Council for Gender Equality, Serbia



Born in 2001 in Arandjelovac, Jovan finished high school with exceptional success. He is currently at his 4th year of academic studies at the Faculty of Diplomacy and Security in Belgrade. Since 2014, he has been dealing with the topics of youth policy, inclusive education, human and minority rights, protection from violence and discrimination, gender equality, as well as regional cooperation in the Western Balkans. He speaks English, Italian and is a certificated peer educator. During his engagement in the Municipal Administration of Arandjelovac, he participated in various projects, like: 1) Promoting dialogue and social cohesion between the Republic of Serbia, Montenegro and Bosnia and Herzegovina; 2) Mitigating the negative consequences of internal migration in the territory of the Municipality of Arandjelovac, 3) Support Local Self-Governments in Implementation of Social Protection Services, 4) Empow-

erment of women in rural areas of the municipality of Arandjelovac in a social and entrepreneurial context.

Ms. Albano is an expert in humanitarian aid, migration governance and anti-trafficking. A lecturer at the Vienna Diplomatic Academy, at Sapienza and Tor Vergata Universities and other think tanks on migration governance and trafficking-related topics, she is the author of various publications, including articles and academic papers.

This committee is responsible among others for LGBTI+, youth, gender and civil socie-ty within the Congress. Andersson is now a member of the social committee in the city of Östersund working with social welfare, inclusion and labour market.

# Gabriel Andrei Brezoiu, President, Group of European Youth for Change (Romania)



Gabriel is a Romanian trainer and project manager specialised in the non-profit field at national and European levels. With over 15 years of experience in youth projects focusing on democracy, digital and entrepreneurship, he is one of the founders of GEYC and the initiator of the PRISMA European Network. He has been trained in over 15 European countries on various topics, with a geographical focus on the Mediterranean area and the Latin America. Back in 2010, he founded the GEYC Community - an innovative platform dedicated for young people in Romania - one of the first European initiatives of digital youth work. In 2018, Gabriel was included in the "Forbes 30 under 30" ranking, most successful youth in Romania.







#### Alice Cardoso, Youth Net, COMECE



Alice Cardoso, 25 years old, is currently working as a freelance translator from English and German to Portuguese. She worked as a Youth Pastoral member in the Diocese of Coimbra and participated in several Portuguese religious activities. Alice is the former director of a youth group in her parish. She was highly involved in the preparation of the World Youth Day Lisbon 2023 edition for three years. Currently she is representing the Portuguese Bishops' Conference in COMECE and volunteering as a Catholic scout's leader.

# Felipe Carvalho, Director of students and young lawyers, Lawyer's Christian Fellowship



Felipe Carvalho is a legal researcher and human rights advocate with a focus on freedom of religion or belief (FoRB) and international refugee law. He currently serves as Director of students and young lawyers at the Lawyers' Christian Fellowship and is a PhD candidate in Public Law at University of Coimbra. Prior to this, he served as Legal Counsel and Executive Director at ANAJURE, where he helped implement a Program designed to resettle and integrate refugees in Brazil, especially victims of religious persecution. In addition to providing legal advice, he has liaised with a variety of organizations to contribute to their integration and co-wrote the book 'Refugees in Brazil'. As part of his engagement with youth, Felipe has co-founded a fellowship program for emerging human rights leaders, which aims to strengthen the advocacy skills and professional network of students and early career lawyers. The

program has trained over 250 delegates in six years.

# Josh Cass, Interfaith Expert



Josh is an experienced interfaith professional currently serving as an advisor (on matters including interfaith dialogue, Freedom of Religion or Belief, faith engagement, and charity strategy) to a number of organisations including the Sigmund Sternberg Charitable Foundation, Culham St Gabriel's, Plan4Peace and Holocaust Memorial Day Trust. Among his many roles, His Eminence has been the President of the Conference of European Churches (CEC), the Assembly of Orthodox Bishops of France, and the Co-President of the World Conference of Religions for Peace (WCRP). Additionally, His Eminence directed the Liaison Office of the Orthodox Church to the European Union in Brussels and spearheads the Interreligious Dialogue initiative with Judaism and Islam on behalf of the Ecumenical Patriarchate.

#### Vera Ferreira, Head of Regional Programmes, KAICIID



Vera is the Head of the Regional Programmes and Oversight Section at KAICIID. On 1 August 2022, Ms. Nazila Ghanea assumed her mandate as Special Rapporteur on freedom of religion or belief. She is Professor of International Human Rights Law and Director of the MSc in International Human Rights Law at the University of Oxford. Her academic work has often connected with multilateral practice in international human rights law. She has contributed actively to networks interested in freedom of religion or belief and its interrelationship with other human rights and has advised states and other stakeholders. She has researched and published widely in international human rights law and served as consultant to numerous agencies.

#### H.Em. Mufti Dr. Nedžad Grabus, Mufti of Sarajevo



Dr. Nedzad Grabus, Mufti of Sarajevo, Islamic Community in Bosnia and Herzegovina, Co-Chair of the Muslim Jewish Leadership Council, Vice President of Religions for Peace: a Professor of theology at the Faculty of Islamic Studies in Sarajevo and the editor of the first interreligious programme in Sarajevo that covered both Islamic and Christian issues, Dr. Grabus is the former Chairperson and a current member of the Assembly of the Interreligious Council in Bosnia and Herzegovina and holds the position of Mufti of the Islamic Community in Bosnia and Herzegovina. Member of the Institute for Ecumenical Theology and Interreligious Dialogue as well as of the editorial board of the Journal for Ecumenical Theology and Interreligious Dialogue "Unity and Dialogue" in Maribor, Slovenia.





#### David Grob, Committee and Board Member, Reformed Church Zürich



Growing up in Switzerland, Mr. Grob has been living in Zurich for 7 years. During this time, he obtained a master's degree in art history at the University of Zurich and a degree in social work with a focus on resocialization and delinquency at the University of Applied Sciences. Mr. Grob started his work experience with the Reformed Church as a youth worker, and today works with homeless people and people suffering from addiction in a diaconal, private institution. David Grob is still active in the Reformed Church, but in a strategic position as a committee member and board member in decision-making bodies.

# Alexandre Guessel, Special Representative on Antisemitic, anti-Muslim and other forms of religious intolerance and hate crimes, Council of Europe



Alexandre Guessel is the Special Representative of the Secretary General of the Council of Europe (CoE) on antisemitic, anti-Muslim and other forms of religious intolerance and hate crimes, since 1 January 2023. Mr. Guessel started working in the CoE in 2000 in the Office of the Human Rights Commissioner. From 2008 to 2010 he served as the CoE's Anti-terrorist coordinator. After having served as adviser in the Private Office of the Secretary General and the Deputy Secretary General from 2010 to 2012, Alexandre Guessel was appointed Director of Political Affairs of the Council of Europe. He remained at this position before being recently appointed as SRSG. Alexandre Guessel graduated from Paris II Assas Law University and has been a member of the Paris Bar Association before joining the Council of Europe.

# Chief Rabbi Schlomo Hofmeister, Community Rabbi of Vienna and Board Member, MJLC



Chief Rabbi Schlomo Hofmeister has been the Community Rabbi of Vienna since 2008. He has received various rabbinic ordinations in different theoretical and practical areas of Jewish Law from some of the most prominent rabbinic authorities. He is a Board Member of the Conference of European Rabbis (CER); the President of the Union of Mohalim in Europe (UME); the Chief Rabbi of Lower Austria, Burgenland, Styria and Carinthia; the Secretary General of the Rabbinical Court of Austria and also the highest rabbinic representative of the Jewish Community of Austria in all interreligious and socio-political matters. He is a lead advocate for interreligious dialogue within the Muslim Jewish Leadership Council.

#### Maryana Hnyp, President, European Network on Religion and Belief



Dr. Maryana Hnyp is Founder and Chair of the KU Leuven Lifestance Network and coordinator of inter-religious and ecumenical relations at KU Leuven. She assumes the post of President of the European Network on Religion and Belief (ENORB). Maryana is Adjunct Professor of Catholic social ethics at the Ateneo university in Manila (Philippines). She holds a PhD in Theology with the specialisation in social and personalist ethics, and an Advanced MA in European Studies from KU Leuven with the specialisation in fundamental rights of the European Union. Dr. Hnyp is also serving as a transcultural psychosocial and psychoeducation consultant for the Ukrainian displaced people at the Centrum Geestelijke Gezondheidszorg Vlaams-Brabant Oost (Vluchtelingenteam). Previously Maryana worked at Caritas Europa, at the Commission of the Bishops' Conferences of the European Community (COM-

ECE), and also assumed served as Director of Religious Education for the international students within the University Chaplaincy of KU Leuven.
